The last lecture in the series arranged by the Australian Association for Psychology and Philosophy (Victorian branch) will be delivered at the University on Monday June 26, at 8 o'clock, in the public lecture theatre, arts building. The lecture will be given by Professor J. A. Gunn, on "The Psychology of Clothes." It will be illustrated with lantern slides. The main purpose of the lectures is to direct attention to the quarterly journal published by the Association, and to attract new subscribers. Annual subscription being 10/-.

The University of Melbourne Press, in conjunction with the Oxford University Press, has published a new and revised edition of a select bibliography of books to read in psychology and philosophy, titled "Psyche and Minerva," compiled by Professor J. A. Gunn.
