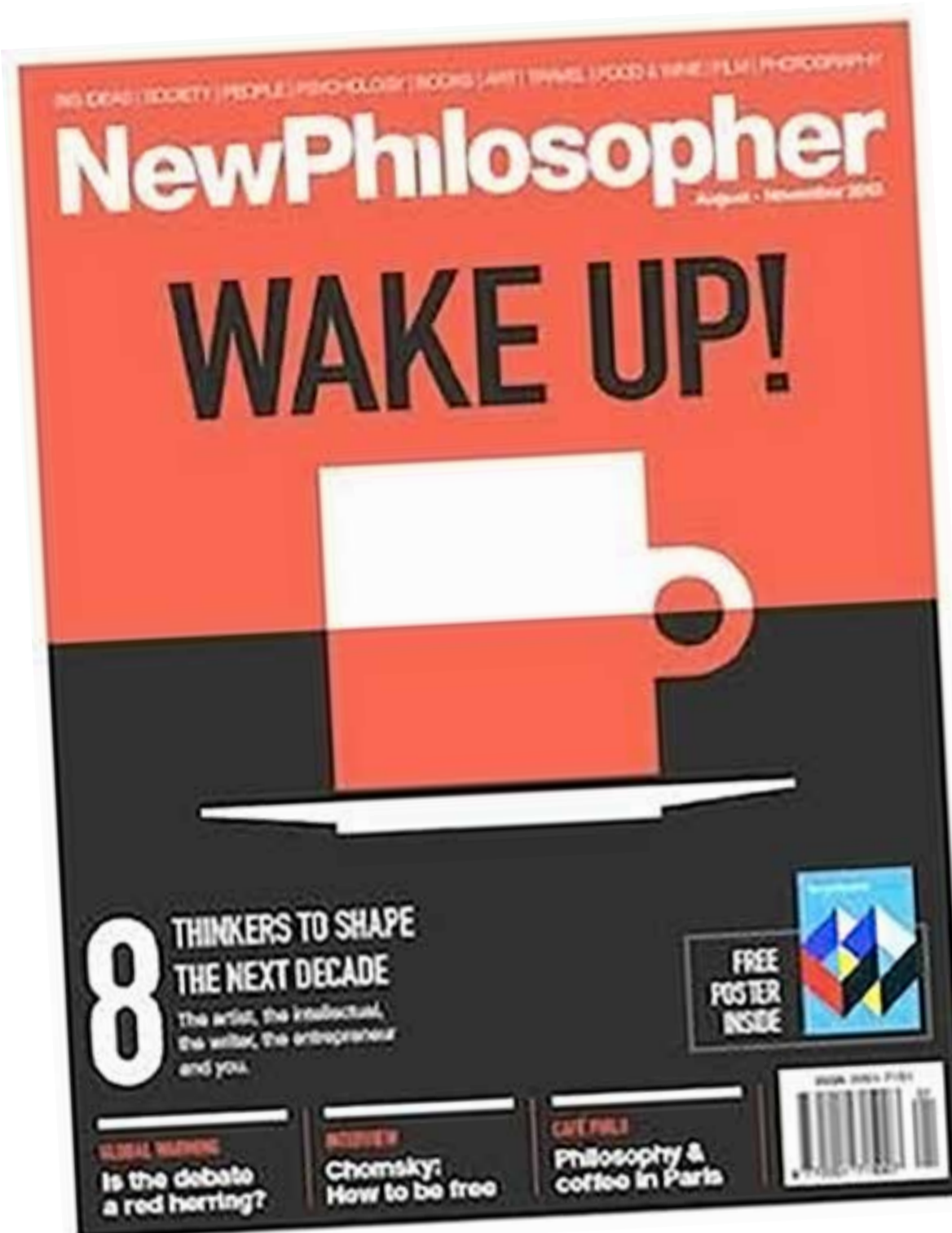

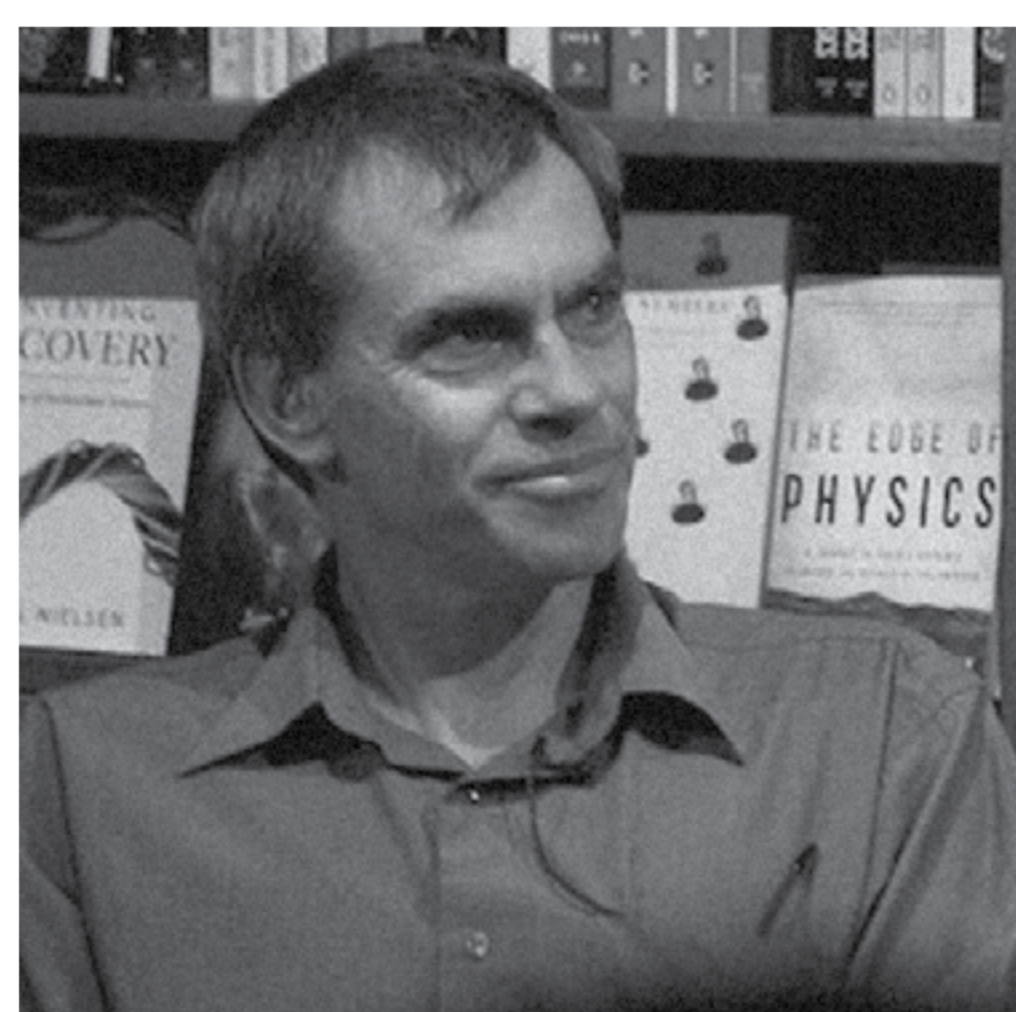

Postgraduate Presentation Prize established to encourage postgraduates to present at the conference, and to recognise the contributions from excellent Australasian postgraduate students. The inaugural prize is awarded to **Tristram Oliver-Skuse** for the paper 'Anger Felt towards a Bin-Licking Dog'.

Association Restructure separates governance from operations, forming a **Board** responsible for governance and oversight of risk, an **Executive** for management, and Committees with responsibility for project and activity implementation. 2016

International Cooperation. Work commences with the American, British and Canadian Philosophical Associations to advocate for discipline interests, including raising concern about department closures and the right to free expression.

Engagement and Impact Consultation. Submission to the Australian Research Council.

Radical Philosophy. Sponsorship of the radio program broadcast on 3CR,



with host and producer **Beth Matthews**. Featuring women philosophers, the program aims to challenge and enlighten the mind by the use of rational argument. 3cr.org.au/radicalphilosophy

2017

Australasian Philosophical Review launches. **Graham Oppy** is the inaugural editor.



2018

Inquiry into Funding Australia's research. In consultation with members, the submission makes recommendations for improving funding of research.

2019



Undergraduate Philosophy Journal of Australasia. Journal launch and awarding

of annual prizes receives AAP support. Editors are members of the Undergraduate Committee.

2020

Online AGM. Pandemic travel restrictions bring about the first online AGM.

2021



Philosothon. After ten years under the oversight of **Matthew Wills**, AAP takes responsibility for the Australasian Philosothon. Organised by the **Philosophy in Community Committee**, it encourages school students to investigate ethical and philosophical questions in the context of "communities of inquiry". **Rob Wilson** with **Karen Bland** are the organisers.

Online Conference. Pandemic travel restrictions bring about the first online conference.

2022

Review of the Australian Research Council Act 2001. Submission with the Australasian Society for Continental Philosophy.

Sagacity, a postgraduate run public philosophy magazine, launches. Originating from members of the Postgraduate Committee, with AAP support.
